RE: Update on Issues – including information on how you can vote on your Collective Agreement

Changes to your Collective Agreement

Your SGEU Health Providers Negotiating Committee has reached a Memorandum of Agreement (MOA) with the Saskatchewan Association of Health Organizations INC. (SAHO). **All SGEU health provider members are entitled to vote on whether or not to ratify this MOA.**

As a result of long-standing discussions with SAHO and the Employer regarding a 10-year old unfair labour practice, the Negotiating Committee has completed negotiations on a resolution, which means each member employed as of May 18, 2021 will receive a lump sum payment of \$200.

The MOA includes:

- A change to the calculation of seniority from the current hours-based system to one based on hire date;
- A one-year extension to the Collective Agreement, which would see the contract expire on March 31, 2023; and
- An additional wage increase in the final year of the Collective Agreement.

Voting will take place online via an easy-to-use tool called Simply Voting, and will begin immediately after the first information session is completed. Voting will close at 5:00 p.m. on July 15, 2021.

Later this month, you will receive an email from SGEU, with the subject line "SGEU Health Providers Ratification Vote" – this email will contain a link to access the virtual Information Sessions as well as instructions and the link to *Simply Voting* so that you can cast your vote. Please keep an eye out for this email, including checking your junk/spam inbox so you don't miss this important information.
